I fully understand that this “activity” involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the “activity”, the conditions in which the “activity” takes place, or the negligence of the “releasees” named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the “activity”.

ABFSC GENERAL ICE RULES

1. Obey all arena rules enforced by the arena personnel.
2. An adult from the ABFSC must be present in the arena before skaters are allowed on the ice.
 - a) **ALL CHILDREN UNDER THE AGE OF 7 MUST BE ACCOMPANIED BY AN ADULT.**
All skaters 5 years or younger are required to wear helmets.
 - b) **No adults or parents are allowed on the ice at anytime unless they are registered as a member.**
(Fee would be \$30.00 for the 2019-2020 season.)
3. No one is ever allowed on the ice when the zamboni is working.
4. Be prompt and well mannered for you appropriate ice time. You are only allowed to skate during your ice time, whether it is badge, junior or senior, unless requested by a pro.
5. **NO FOOD, GUM OR DRINKING IS ALLOWED ON THE ICE.**
6. The ice is for skating, not for socializing. If you are not skating, get off the ice. Standing around or horseplay on the ice or near the boards will not be tolerated.
7. Get up from a fall as quickly as possible if you are not hurt. Report any serious injury to a responsible adult.
8. Be polite at all times, including your words, actions towards other skaters, pros, and adults. Failure in using appropriate behavior will result in parental notification and/or loss of club privileges.
9. It is your responsibility to check the club bulletin board for announcements and ice schedule changes during the skating season.
10. **NO CELL PHONE USE IN THE LOCKER ROOMS.** If you need to use your phone it has to be done out of the locker room.
